McNulty Encourages Bush and Baker to deny Arafat a Visa

First year US Representative Michael McNulty wrote to President Bush on September 14, urging Bush and Secretary of State James Baker to deny Palestinian President Yasir Arafat a visa to speak at the United Nations (UN), should he seek a visa.

The letter (which is included in this Newsletter) was full of scorn for the Palestinians and the UN. It began with, "I write to voice my grave concern at the possibility that Yasir Arafat, the head of the terrorist Palestine Liberation Organization,...". His letter was incredibly insulting to the Palestinian people. In his three page letter, he repeatedly referred to Palestinians as terrorists, he did not say anything positive about the Palestinians, nor did he say anything the slightest bit critical of the Israelis. He concluded his letter by stating that refusing a visa is in "the best interests of the United States, the state of Israel—our staunch and only democratic ally in the Middle East—and the peace process to which you have given so much impetus".

McNulty said it was legal for the US to deny Arafat a visa. He did not mention the 1947 headquarters agreement the US has with the UN in which the US agreed to allow invited guests of the UN permission to enter the US in order to attend UN sessions in New York City.

The Capital District Committee for Palestinian Rights encourages people to contact Mr. McNulty at (518)-465-0700 and let him know that his views on the Palestinian-Israeli conflict are badly out of tune with the sentiments of the American people. He should also be told that constantly referring to Palestinians as nothing but terrorists is racist and unacceptable.

Israel Asks for Trouble in Occupying Lebanon By James Zogby* (Los Angeles Times/Tuesday, August 8,1989)

In all of the reporting on the kidnapping of Sheikh Abdel Karim Obeid and the execution of Lt. Col. William R. Higgins, very little attention has been paid to a key element in these events: Israel's continuing occupation of Southern Lebanon.


Obeid was a Muslim preacher in a village in that region and well-known to Israeli authorities. After his abduction, the Israeli military described him as an "inciter" of violence and the mastermind behind "attacks" against Israel". But almost immediately, the government radio was reporting the possibility of swapping him for three Israeli soldiers believed taken by Shiite forces in the area. The Israeli spin doctors went to work. Obeid, snatched from his home and family in the middle of the night, was now a hostage being offered for trade. His kidnapping was now an "arrest", and the three missing military men, prisoners of war, were presumably "hostages".

One can reasonably ask whether the designers of the operation against Obeid foresaw the twists and turns that it would produce. Regardless, the Israeli image machine lost no time in keeping up with the changing headlines. At one point they sought to implicate Obeid in everything from the holding of U.S. hostages in Lebanon (which, it should be noted, was not one of their initial charges) to the planning of the Pan Am Flight 103 bombing. At week's end, Defence Minister Yitzhak Rabin was taking credit for refocusing U.S. attention on our hostages in Lebanon, whom he said, Washington had forgotten "but we have never forgotten".

Spin aside, Obeid's kidnapping was not intended to serve U.S. interests or to secure the freedom of U.S. hostages. In fact, only a month earlier a high Hezbollah leader indicated the possibility of movement toward their release. Obeid was taken simply to secure Israel's control over Southern Lebanon.

Isræli Defence Forces first invaded and seized Lebanese territory, up to a depth of more than 10 miles, in 1978. They have continued to control this area, under military administration, ever since. In addition to

their direct presence, the Israelis also sponsor, fund, train and arm a surrogate force called the South lebanon Army (which is a militia, not a government army) at a cost of some \$30 million a year.



Israeli (sic) withdrew to the 10 miles north of the border in 1985 after ill-fated march on Beirut, giving the world impression that occupation was temporary. Economic Strangulation, Oppression & Mobilization By Amy Trabka

Ilthough our media coverage of the Palestinian Uprising has diminished, Within Occupied Palestine, daily resistance and the accompanying pasualties are a continuing reality. During the month of June, I had the apportunity to visit the West Bank and experience some of the resistance and repression first hand.

Farmers are no longer able to obtain permits to export fruits and vegetables to In an attempt to Jordan. advantage of the low prices of these "locked in" commodities, women's committees have established small cooperatives to produce fruits and vegetables for home consumption and local distribution. Their small scale precludes licensing requirements and

subsequent repression. However because of reduced sales from shorter hours of operation and a scarcity of cash among the economically strained population, businesses have been devastated by the exorbitant taxes being levied by the Israeli civil administration to finance the huge cost of occupation. Although many businesses have refused or delayed paying taxes as a form of eventually resistance, administration finds ways collection, such as setting up check points until payment is made. At that time the merchant may have to come up

with, not only the tax, but also an additional 500% penalty as well as taxes in advance. year's Frequently this additional burden is enough to put a small merchant out of sources of business. Additional funding the occupation are exorbitant automobile registration fees (\$1500), license plate costs (\$700) and high premiums for policies insurance available now only through the state.

In the town of Ramallah, about 20 Kilometers from the village where I was staying, demonstrations occurred daily with the army responding to road blocks, burning tires and stones with gunfire; first olanks, then tear gas and ammunition. Frequently, live demonstrations and army response shut lown large sections of the town even pefore the regular 12 noon shop The demonstrators closings. who respected by the population, follow their directions for road blocks and rerouting traffic. Pre-dawn raids on villages and neighborhoods continue in an attempt to find persons suspected resistance activity. These accompanied by vandalism (smashing glass in rooftop solar heaters) and theft. Women in the village where I stayed complained of being locked into one room of their house while searched the other soldiers rooms, confiscating life savings (most villagers do not have bank accounts, savings are stored Home). Gold jewelry, was also missing after army searches. Since these raids have occurred continuously, those who are wanted by the army have been sleeping in the hills outside of the village for the last two years in order to avoid arrest. Family members beaten severely been frustrated soldiers trying to force information of their whereabouts. Those who are detained are made to ride on the floor of buses to the army compound where they are kicked and hit by the arresting soldiers. Some of those who are arrested , even if they are not charged with any more established members

Also commemorated during my stay was the death on June 4th of Omar Qassem, a Palestinian resistance leader who died in prison after serving 21 years of a life sentence. About 8000 Palestinians participated in his funeral in Jerusalem, while symbolic funerals were held in other towns.

With the realization that actual independence will take a long time to achieve, the Palestinian people are gradually but steadily working toward independent creation of an economic and political infrastructure on which to build their new state. Originally initiated by the young activists in coordination with the Unified National Leadership, older, of

Currently visiting Washington, the governor of the district, Halim Fayyad, characterizes the situation as part of Israel's "imperial designs" on Lebanon . "They seek to expand borders and gain rich water resources", says Fayyad, and do so "in the name of their national security".

The U.S. has refused to press Israel to withdraw from Southern Lebanon and to enforce U.N. Resolution 425, which calls for the withdrawal and for the securing of the region under U.N. forces. This has left the Lebanese who want to regain sovereignty over the territory no recourse but to wage a war of national resistance.

While the Israeli propaganda machinery describes the resistance forces as terrorists, it requires a remarkable contortion of logic to define attacks against an occupation army as anything other than legitimate resistance.

In fact, it would seem more appropriate to describe the forced expulsion of thousands of land, the use Lebanese from their collective punishment against entire villages, and the prolonged detention of male leaders without charges or due process as a form of terrorism. After all, the accepted definition of terrorism is the use of force against noncombatants in order to create fear intimidation for the achievement of political objectives.



Noted Pakistani Scholar Eqbal Ahmad Lectures About Palestinians at RPI

On Sept. 28, Egbal Ahmad lectured for about two hours about the Palestinian-Israel conflict at RPI.

About 70 people attended.

Dr. Eqbal said that he is struck by how Little interest there is in the US in hearing both sides of this issue. He described the Israeli policy towards the Palestinians as genocide. He said genocide is done either through murder or the taking away from the victims, their land, water, leaders, and culture. Dr. Eqbal; said, Israel now controls 85% of the water, 60% of the farmable land in the occupied territories, and the Israeli prisons are filled with Palestinian leaders and Israel is destroy to attempting Palestinian Institution.

Dr. Eqbal described the Intifada an "extraordinary event", unprecedented in history. He said the "Israeli goal is to eliminate the Palestinians". Expulsion has now become "transfer", the same word the Nazis used during the first years of their regime. He also said "Palestinians are an abandoned people". They can only go to the American people, because the US government is a party to conflict, or to Israel. He said "The Palestinian is the shadow of the Tew... and he will not leave until his is embraced". And added the merely "Palestinians are not destroy terrorists who want to Israel, or freedom fighters, or fighting for their selfdetermination; they are fighting for their survival".

Dr. Eqbal said that Zionism has nothing to do with the liberation of the Jewish people, but it is a movement for a Jewish state and is unconcerned about the Jewish people. He also said it is incorrect to say that the Arab governments strongly support Palestinian rights, but they

Times Union runs Racism Series, Omits any Discussion of Anti-Arabism

For seven days, beginning on october 22, the Albany Times Union News Paper ran a series of articles on racism in the Capital District. There was plenty of discussion of racism against blacks and Jews, but nothing about racism against Palestinians and other Arabs.

Michael Winograd, the Regional Director of the ADL was quoted twice during the series. In the article on 10/27, he made comments that surely applied to himself and the ADL. He said, "What people say and what they do are two different things. There are a lot of closet bigots. There is a whole range of bigotry from very polite background bigotry to actual violence. A lot of people who claim not to be bigoted have bigoted attitudes".

This the same Mr. Winograd who two years ago had a letter printed in the Schenectady Gazette describing the


PLO as a terrorist organization. One time when I asked him what is the difference between a Palestinian killing a Jew in cold blood and a Jew killing a Palestinian in cold blood, he said the former is "terrorism", the latter "terrible". This the same Winograd who has refused to acknowledge that it is repugnant for the ADL to run both an anti-prejudice campaign (A World of Difference) and (the ADL's prejudice campaign decades long proactive of publishing books and articles about what it calls Palestinian and Arab terrorism and Arab anti-Semitism) simultaneously.

On August 23, on a live TV show on Aube CPR member David challenged Mr. Winograd about the ADL's two-faced approach to prejudice and he replied that he and Mr. Aube have had differences on this issue. He refused to discuss the substance of the CPR charge. Thousands of the Capital District residents saw this

cowardly response.

I called the Times Union reporter Tim Beidel and told him about the ADL and its prejudice record, but the Times Union refused to include anything about it in its series of articles.

It is a shame that while there is a tremendous amount of discussion of prejudice against Jewish people, there is virtually no discussion of prejudice by Jewish people. CPR Members meet with Bishop Hubbard

On October 24th, three members of the Capital District Committee for Palestinian Rights met with Howard Hubbard, Bishop of the Albany Roman Shelia Oweida, Diocese. Catholic Zahrey, and Tom Faisal discussed a variety of issues during the 70 minute meeting.

The meeting had been requested by CPR members to discuss the Bishop's accepting an award last June from the virulently Anti-Arab Anti-Defamation League of B'nai B'rith (ADL). Bishop Hubbard said he would not apologize for accepting the award, but said the packet of information provided to him by the CPR documenting the ADL's long hostile negative bitterly stereotyping campaign of Arabs and its intimidation of people, including religious leaders, who speak out in support of Palestinian rights, was a "strong indictment" of the ADL.

The Bishop stated there is a major distinction between the political Israel-Palestinian conflict and the interreligious activities between Christians and Jews. In response to that, we said that this is correct but there are many Jewish people who do not make distinction and that it was painful for us to see the Bishop socializing with Jewish leaders who refer to us as anti-Semitic criticizing Israel. Father Hubbard said he has told Jewish audiences that it was inappropriate for them to label critics of Israel as anti-Semites. He also added that at times when he speaks in synagogues, he has spoken out in support of Palestinian rights.

CPR members asked him if he would hold a memorial service for the victims of the Intifada and he said that he would consider it, but not until after a November conference of US bishops in Baltimore. The Bishop will be finalizing a policy statement on "Toward Peace in the Middle East: Problems and Principles". He said,



Dear Mr. President:

I write to voice my grave concern at the possibility that Yasir Arafat, the head of the terrorist Palestine Liberation Organization, may-upon his request-be granted a visa to visit the United States for the purpose of addressing the United Nations.

There is no question in my mind, Mr. President, that granting a visa to Mr. Arafat will undermine all you have done to promote the peace process in the Middle East over the last nine months.

Mr. Arafat heads an organization that still supports and engages in terrorist activities, including numerous assassinations.

PLO terrorism is being used not only against Israel but also against Palestinians, who disagree with the PLO, including those who favor negotiations with Israel and those who do not agree that the PLO represents all Palestinians resident in Israel, in Jordan, on the West Bank, or in Gaza. That terrorism has taken hundreds of American and Israeli lives, and not once has Yasir Arafat renounced such terrorist acts.

On the contrary, on January 1, 1989, our Embassy in Riyadh recorded a message from Mr. Arafat in which he states: "Whoever thinks of stopping the intifada before it achieves its goals, I will give him 10 bullets."

Despite his public declarations last December, numerous statements by Mr. Arafat and other senior PLO officials make clear the PLO's continuing commitment not only to the Cairo Declaration of November 1985, which called for terrorist operations against Israel, but also the elimination of Israel.

As recently as last month, the 1200 delegates attending the 5th General Congress of the Fatah Movement's Revolutionary Council in Tunis--Mr. Arafat's own constituent within the Palestine Liberation Organization--adopted a commitment for "Continuing to intensify and escalate armed action and all forms of struggle to liquidate the Israeli-Zionist occupation of our occupied Palestinian land and guaranteeing our people's right to freedom, and independence."

On what basis, then, Mr. President, can we justify granting a visa to Mr. Arafat? Do we permit him into the United States to address the opening session of the United Nations General Assembly on September 25? Of course not. The opening session of the United Nations is addressed and/or attended only by heads of state. To permit him to come to this session would constitute implicit recognition for the non-state for which he seeks United States recognition.

Do we, on the other hand give him a visa to participate in the United Nations general debate on the Israel-Palestinian issue, scheduled for November of this year? Of course not for the following reasons:

- * Mr. Arafat and his PLO have been actively seeking support for an international conference on the Middle East, and has mobilized considerable support for his position within the United Nations. His appearance before that body will put the international conference on the UN agenda. The United States and Israel are opposed to such a conference for good and valid reasons.
- * By coming before the United Nations, Mr. Arafat will be perceived not as one who is against peace in the Middle East, but as one who embraces the idea of an international conference. With the kind of support he has in the United Nations, this would place the United States in an extremely difficult and disadvantageous position.
- * If the United States accedes to the will of the United Nations, the peace process is ended.
- * If the United States opposes the international conference within the United Nations setting, the pressures upon us will be so great that the peace process will be ended.

What can take place under the circumstances outlined above can have a reverse policy effect for the United States.

In addition, as you well know, Mr. President, there is a legal basis for barring Mr. Arafat's entry into the United States under Public Law 80-357.

As our Ambassador on October 6, 1972, you yourself explained to United Nations Secretary-General Kurt Waldheim a decision to bar Dia-Allah El-Pattal, the head of the International Organizations Department of the Syrian Foreign Ministry, from joining his country's delegation in the General Assembly. This exclusion resulted from his recruiting individuals for terrorist operations of the Palestine Liberation Organization.

It was under this section of Public Law 357 that former Secretary of State George P. Schultz barred Mr. Arafat's entry into the United States, citing the Chairman's "associations with terrorism." And, as you know, Mr. President, there have been a number of other less publicized cases.

For all of these reasons, I urge you to deny Yasir Arafat a United States visa that would enable him to participate in the proceedings of the United Nations. I sincerely believe this to be in the best interests of the United States, the State of Israel—our staunch and only democratic ally in the Middle East—and the peace process to which you have given so much impetus.

A YEAR OF INTIFADA

The Palestinian/Israeli conflict has changed dramatically since the beginning of the Intifada on December 8,1987. Of primary importance, the Declaration of Independence of November 15th brought the long sought Palestinian State into existence. More than 70 countries have recognized the new state. The PLO's observer mission at the UN is now referred to as "Palestine".

The Intifada has conferred a powerful international legitimacy for the Palestinian cause. In addition, the image of Israel as a moral and democratic state has suffered profound setbacks. More Americans, including supporters of Israel, have been speaking out. There has also been a weakening of AIPAC.

The Palestinians have clearly seized the political initiative. After being denied an opportunity by the U.S. to speak at the UN in NYC, the General Assembly convened in Geneva and Chairman Arafat was heard. The visa denial and Arafat's UN speech clearly showed U.S. isolation. In December the U.S. announced it will open a "diplomatic dialogue" with the PLO.

The Palestinians in the Occupied Territories have created a tremendous network of self help popular committees. Individuals from various PLO parties in the Occupied Territories, (Fateh, Popular Front, Democratic Front, the Communist Party, and in Gaza, Islamic Jihad) have formed the clandestine Unified National Leadership of the Uprising.

The reaction from Israel is ominous. There has been a shift to the right in the recent Israeli coalition government and Labor and Likud is united in their rejectionism of PLO peace initiatives. The talk of transfer (forced mass expulsion) has been legitimized in mainstream discourse. Murderous attacks on Palestinian workers staying overnight in Israel have occurred, and Israeli Death squads are operating in the Occupied Territories.

The significant achievements of the Palestinian people in 1988 is due to the courage and creativity of the Intifada. The costs have been high; hundreds of Palestinians have been killed, over 20,000 Palestinians have suffered injuries warranting hospitalization, 47 individuals have been expelled, 400 houses have been demolished and sealed, over 100,000 fruit and olive trees uprooted, medical supplies interrupted and the arrested have been held in mass detention centers.

In the Capital District supporters of Palestinian rights must not let this historic moment pass. We must stand in full solidarity with the Palestinians under occupation and increase our efforts toward their quest for freedom, dignity, and self-determination. All of us must unlock previously untapped resources and increase our strength in unified actions.

The Palestinian Declaration of Independence, 15 November 1988

Palestine, the land of the three monotheistic faiths, is where the Palestinian Arab people was born, on which it grew, developed and excelled. The Palestinian people was never separated from or diminished in its integral bonds with Palestine. Thus the Palestinian Arab people ensured for itself an everlasting union between itself, its land and its history...

It was the Palestinian people, already wounded in its body, that was submitted to yet another type of occupation over which floated the falsehood that "Palestine was a land without people". This notion was foisted upon some in the world, whereas in article 22 of the Covenant of the League of Nations (1919) and in the Treaty of Lausanne (1923), the world had recognised that all Arab territories, including Palestine, of the formerly Ottoman provinces, were to have granted to them their freedom as provisionally independent nations.

Despite the historical injustice inflicted on the Palestinian Arab people resulting in their dispersion and depriving them of their right to self-determination, following upon UN General Assembly Resolution 181 (1947), which partitioned Palestine into two states, one Arab, one Jewish, yet it is this resolution that still provides those conditions of international legitimacy that ensure the nght of the Palestinian people to sovereignty and national independence.

By stages, the occupation of Palestine and parts of other Arab territories by Israeli forces, the willed dispossession and expulsion from their ancestral homes of the majority of Palestine's civilian inhabitants, was achieved by organised terror, those Palestinians who remained, as a vestige subjugated in their homeland, were persecuted and forced to endure the destruction of their national life.

Thus were principles of international legitimacy violated. Thus were the Charter of the United Nations and its resolutions disfigured, for they had recognised the Palestinian people's national rights, including the right of return, the right to independence, the right to sovereignty over territory and a homeland...

The massive national uprising, the "intifada", tow intensifying in cumulative scope and power on occupied Palestinian territories, as well as the unflinching resistance of the refugee camps outside the homeland, have elevated

consciousness of the Palestinian truth and right into still higher realms of comprehension and actuality. Now, at last, the curtain has been dropped around a whole epoch of prevarication and negation. The intifada has set siege to the mind of official Israel, which has for too long relied exclusively upon myth and terror to deny Palestinian existence altogether. Because of the intifada and its revolutionary irreversible impulse, the history of Palestine has therefore arrived at a decisive juncture.

Whereas the Palestinian people reaffirms most definitively its unalienable rights in the land of its patrimony:

- now by virtue of natural rights, and the sacrifices of successive generations who gave themselves in defence of the freedom and independence of their homeland;
- in pursuance of resolutions adopted by Arab summit conferences and relying on the authority bestowed by international legitimacy as embodied in the resolutions of the United Nations Organisation since 1947:
- and in exercise by the Palestinian Arab people of its rights to self determination, political independence, and sovereignty over its territory.

 the Palestine National Council, in the name of God, and in the name of the Palestinian people, hereby proclaims the establishment of the State of Palestine on our Palestinian territory with its capital Jerusalem.

The state of Palestine is the state of the Palestinians wherever they may be. The state is for them to enjoy in it their collective national and cultural identity, theirs to pursue in it a complete equality of rights. In it will be safeguarded their political and religious convictions and their human dignity by means of a parliamentary democratic system of governance, itself based on freedom of expression and the freedom to form parties. The right of minorities will duly be respected by the majority, as minorities must abide by decisions of the majority. Governance will be based on principles of social justice, equality and non-discrimination in public rights, men or women, on grounds of race, religion, colour or sex, under the aegis of a constitution which ensures the rule of law and an independent judiciary. Thus shall these principles allow no departure from Palestine's ancient spiritual and cultural heritage of tolerance and religious coexistence.

The state of Palestine is an Arab state, an integral and indivisible part of the Arab nation, at one with that nation in heritage and civilisation, with it also in its aspiration for liberation, progress, democracy and unity. The state of Paiestine affirms its obligation to abide by the charter of the League of Arab States, whereby the coordination of the Arab states with each other shall be strengthened. It calls upon Arab compatriots to consolidate and enhance the emergence in reality of our state, to mobilise its potential and to intensify efforts whose goal is to end Israeli occupation.

The state of Palestine proclaims its commitment to the principles of the UN, and to the universal declaration of human rights. It proclaims its commitment as well to the principles and policies of the Non-Aligned Movement.

It further announces itself to be a peace loving state, in adherence to the principles of peaceful coexistence. It will join with all states and peoples in order to assure a permanent peace based upon justice and the respect of rights so that humanity's potential for well-being may be assured, an earnest competition for excellence be maintained, and in which confidence in the future will eliminate fear for whom justice is the only recourse.

In the context of its struggle for peace in the land of love and peace, the state of Palestine calls upon the United Nations to bear special responsibility for the Palestinian Arab people and its homeland. It calls upon all peace and freedom loving peoples and states to assist in its attainment of its objectives, to provide it with security, to alleviate the tragedy of its people, and to help it terminate Israel's occupation of the Palestinian territories.

The state of Palestine herewith declares that it believes in the settlement of regional and international disputes by peaceful means, in accordance with the UN Charter and resolutions. Without prejudice to its natural right to defend its territorial integrity and independence, it therefore rejects the threat or use of force, violence and terrorism against its territorial integrity, or political independence, as it also rejects their use against the territorial integrity of other states...

Therefore, we call upn our great people to rally to the banner of Palestine, to cherish and defend it, so that it may forever be the symbol of our freedom and dignity in that homeland, which is a homeland for the free.

PRO-PALESTINIAN RESOLUTION WINS VOTER APPROVAL IN CAMBRIDGE, MASSACHUSETTS

During the recent elections in the US, voters in Cambridge, MA passed a resolution calling for a reduction in US aid to Israel equal to what Israel spends in the West Bank and Gaza Strip. The vote was 22,784 for and 20,456 against. This referendum demanded the district's state representatives to send a message to the President and Congress "to achieve a just and lasting peace in the Middle East by:

1) demanding that Israel ends its violations of Palestinian human rights and its occupation of the West Bank and Gaza."

A similar resolution in nearby Newton, MA and two others in California were defeated, in part to intense campaigns by many Jewish groups and other supporters of Israel.

In Newton, a resolution calling upon the US govt. to "support the principles of self-determination for the Israeli and Palestinian people; the creation of a Palestinian state in the West Bank and Gaza Strip next to Israel, and security for Israel and the new Palestinian state" was defeated by about a 2 to 1 margin.

The referendum on the ballot in San Francisco stated that seeing as the US already recognizes Israel and that a comprehensive Middle East peace "may be achieved only by the mutual recognition of the national and human rights of both the Israeli and Palestinian peoples", "It is therefore resolved that the people of San Francisco join the vast majority of the people of the world in calling upon the United States government to expand its policy to include: United States recognition of the Palestinian people's right to self-determination and statehood in the occupied terrorities of the West Bank and Gaza side by side with the state of Israel with guarantees for the security of both states."

Sadly, this resolution was loudly attacked by many Bay-area Jewish groups as being anti-Israel. More than 63,000 persons voted in favor while over 133,000 opposed it.

A voter referendum in Berkley which would have established Berkley as a sister city of the Jabalya refugee camp in Palestine gained more than 13,000 votes for and over 31,000 opposed to it.

The Northern California Jewish Bulletin of November 11 reported that both the Bayarea "No" campaigns outspent the "Yes" campaigns by more than 10 to 1.

Although the Pro-Palestinian referendums were defeated in three of the four localities, supporters were still glad that they had made the effort.

Hilton Obenzinger, who is on the Executive Committee of the Palestine Solidarity Committee, said the lesson from the great victory in Cambridge is that "Voters can be convinced to challenge the political establishment once they realize that we are paying for Israel's human-rights abuses."

INTIFADA VICTIMS MEMORIAL SERVICE HELD IN SCHENECTADY

On December 11, 1988, the Palestinian Committee members commemerated the first anniversary of the Intifada. A memorial service "for those who have perished in Uprising on the Occupied Territories of the West Bank and Gaza" was held at St. George's Greek Orthodox Church in Schenectady, New York. Father Anthony Nichlas performed the ceremony after the regular Sunday service. The memorial service included "rah me," a mercy offering containing wheat wrapped around a kafiya. A coffee hour was held afterward at which Committee members conversed with parishiners and information leaflets were distributed.

During the memorial serice, Father Nichlas read two letters. The first was from the Archbishop of the Greek Orthodox Church of North and South America. The other was from the Metropolitan Philip of the Antiochian Orthodox Christian Archdiosese of North America. The first letter said, "How ironic that in the promised land, once again we see the slaughter of children along with a majority of the young people." The second letter included: "May we join our prayers to yours for the victims who are struggling just to survive and for those martyrs who have given their lives so that their children...will one day be freed from the Zionist Occupation of their lands."

The Palestinian Committee greatly appreciates the efforts of Father Nichlas for organizing this event and the parishiners for the use of the church.

THE PALESTINE LIBERATION ORGANIZATION

The PLO has been very active in the latter part of 1988 - declaring an independent state, pursuing a vigorous peace initiative, and negotiating with the US. Despite all these activities, the history and nature of the PLO has never been properly articulated in the mainstream US media.

Basically, the PLO is the national liberation movement of the Palestinian people. It is the institutional expression of Palestinian nationhood, the Palestinian's instrument in the struggle for the attainment of their usurped national rights, and their organized effort to reconstitute their shattered and dispersed society.

In 1964, the Arab League empowered Ahmad Shugairy to formulate the PLO. The Arab League's reasoning was twofold - to control individual Palestinian liberation efforts and to cover their own ineptitude in dealing with Zionism. On May 28, 1964, in Jerusalem, 422 Palestinians, mostly from elite circles, gathered for the first session of the Palestinian National Council (PNC).

Throughout the 1950's and 1960's, many individual fedeyaan organizations had developed and they saw the PLO as a tool of Arab governments. The June 1967 war proved to the Palestinians that Arab countries could not liberate Palestine. Shugairy resigned at the end of 1967 and was replaced by Yehya Hammoudeh, who had promised radical reforms. The fedayeen organizations participated in the 4th PNC session (7/68) and at the 5th PNC session (2/69), Mr. Arafat was elected Chairman of the PLO. It was during this period when the PLO began to represent all sectors of the Palestinian people.

After the 1967 war, the PLO built social, political, and military institutions in Jordan. However, in Sept., 1970, a civil war broke out and the PLO was forced to reorganize in Lebanon. The PLO was primarily based there until 1982 when the Israelis invaded. Within the last few years, the PLO has returned to Lebanon. The Headquarters are presently located in Tunis, Tunisia.

After the October war of 1973, the PLO regained the historical initiative and it was determined to seek international recognition. In 1974, the Arab League and the Non-Aligned Countries gave recognition to the PLO as the sole, legitimate representative of the Palestinian people. Also in 1974, the United Nations (UN) gave the PLO observer status and membership in all sub-organizations. On Nov. 13, 1974, Chairman Arafar delivered a speech to the General Assembly.

In June 1980, the European Economic Community (EEC), in its Venice Declaration, recognized the Palestinian's right to self determination and called for PLO participation at an international peace conference. The number of nations that today recognize the PLO is twice the number that recognize Israel.

The political program of the PLO has evolved through many stages: 1) 1964 - to liberate all of Palestine from the Zionists and establish an independent Palestinian state. 2) 1968 - a democratic secular state in Palestine. 3) 1974 - an independent national authority on any part of liberated Palestine. 4) 1977 - an independent Palestinian state on any part of liberated Palestine. 5) 1982 - acceptance of the Fez Arab Summit Plan which called for a two state solution and the right of all states in the region to live in secure borders. 6) 1988 - an international peace conference with all parties to the conflict participating, including the PLO, on the basis of UN resolutions 242 and 338, and the safequarding of Palestinian national rights.

A major component of the PLO are the social and cultural institutions. The PLO is committed to meeting the functional needs of the Palestinian people, with a focus on children and the development of a sense of selfworth. The following are examples of major institutions: The Palestine Red Crescent provides medical and health care and is a member of the International Red Cross. The Samed Martyrs Works Society provides for the economic infrastructure. The Dept. of Culture and Information preserves and develops Palestinian arts and maintains worldwide media systems. Popular organiza-

tions such as unions provide the democratic structure of the PLO. Since the early 1970's, a grass roots network has existed in the Occupied Terrorities. As the Inifada has progressed for a year, a national economy has developed. This network will become the infrastructure of the Palestinian state.

PLO political institutions resemble parliamentory democracies. These include the National Council, the Central Committee, and the Executive Committee. The Palestine National Council (PNC) is the highest policy making body. It represents the entire spectrum of Palestinian society. The PNC has proportional representation from the commando groups, mass movements and trade unions, professional organizations, communities in the diaspora, Palestinians who have been expelled from Palestine, scientists and intellectuals, and independents. Palestinians from the Occupied Terrorities are represented. However, they are threatened with expulsion if they participate.

The Central Committee consists of 60 PNC members. It serves a combined legislative- executive function. The Executive Committee has 15 PNC members and it functions as the executive branch of government. Each member has a portfolio. The Chairman of the Executive Committee is the Chairman of the PLO.

The fedeyaan organizations are at once independent of the formal structure of the PLO and integrated within it. They have representation in all PLO institutions. It is more accurate to refer to these groups as political parties than factions. Each group differs on how to accomplish a Palestinian homeland. Intense debates are constantly held in the search for concensus and unity.

In its nearly 25 year history, the PLO has matured politically and socially into a reasonable responsible member of the global community. Presently the PLO is pursuing a vigorous worldwide peace initiative as well as strengthening and developing the Palestinian state through the Intifada. It is crucial for supporters of Palestinian rights to support the PLO; they are clearly the chosen representative of the Palestinian people.

THE PALESTINE NATIONAL COUNCIL Political Resolutions, Excerpts

rights, and stemming from its desire for peace expressed in the Declaration of Independence proclaimed on 15 November 1988. the PNC affirms the commitment of the Palestine Liberation Organization to seek a comprehensive political settlement to the Arab-Israeli conflict and the Palestine question. This search for peace shall be within the framework of the United Nations Charter, the principles and provisions of international legality, he priciples of international law, U.N. and Arab summit resolutions which quarantee the Palestinian Arab people the right to return, the right to self-determination and the right to establish their independent state on their national soil with peace and security for all states in the region.

In the pursuit of these objectives, the PNC calls for:

I- The convening of an effective international peace conference on the Middle East and the Palestine question under the auspices of the United Vations and with the participation of the permanent members of the Security Council and all parties to the conflict, including the PLO, the sole legitimate representative of the Palestinian people, on equal footing with the other parties.

The international conference is to convene on the basis of U.N. Security Douncil Resolutions 242 and 338 coupled with the legitimate rights of the Palestinian people, including above all their right to self-determination in accordance with the principles and provisions of the U.N. Charter relevant to the principle of national self-determination, the inadmissibility of the acquisition of territory by force, and according to U.N. resolutions relevant to the Palestine question.

- 2- Israeli withdrawal from all Arab and Palestinian territories occupied since 1967, including Arab Jerusalem.
- 3- The nullification of all annexation measures and the dismantlement of settlements established by Israel on Palestinian and Arab land since 1967.
- 4- The placement of the occupied Palestinian territories, including Arab lerusalem, under U.N. supervision for a limited period of time to protect our people and create a climate conducive to the successful convening of the international peace conference and reaching a comprehensive political settlement to bring peace and security for all through mutual acceptance, and to enable the Palestinian State to exercise its effective authority over these erritories.
- 5- Solving the Palestine refugee problem in accordance with pertinent U.N. resolutions.
- 6- The freedom of worship and religion and access to the holy places in Palestine are guaranteed for all faiths.
- 7- The Security Council shall establish and guarantee security arrangements between all the interested parties in the region, including the State of Palestine.

The PNC reaffirms its earlier resolutions concerning the distinctive fraternal relations between the Palestinian and Jordanian peoples. It also affirms that the future relation between the states of Jordan and Palestine shall be based on the concept of confederation and free and voluntary choice by both peoples to strengthen their historic ties and vital common interests.

The PNC also reaffirms its adherence to U.N. resolutions which approve of the right of peoples to resist foreign occupation, imperialism and racial discrimination, and their right to struggle for independence. The Council proclaims anew its rejection of terrorism in all its forms, including state terrorism, in accordance with earlier resolutions on this matter and other pronouncements such as the Arab summit resolutions in Algiers in 1988, U.N. Resolutions 42/159 (1967) and 61/40 (1985), and the PLO Cairo Declaration of 7 November 1985.

PALESTINIAN WORKERS NEED

Last November, the Palestinian Committee mailed a packet of information concerning viclations of Palestinian union and workers rights by the Israelis to people in the Capital-area active in organized labor. During the last few months, the American-Arab Anti-Discrimination Committee (ADC) has been successful in petitioning the US Trade Representative to schedule hearings on the Israel's brutal suppression of Palestinian workers' rights. The hearings had originally been scheduled to occur prior to the US elections but were postponed.

The US Trade Representative has the power to repeal Israel's duty-free trade status with the US if Israel is found to be employing improper labor practices.

Such a decision is considered unlikely in view of George Bush's antilabor history.

concluded its first active year with a pair of events. On November 29th, The International Day of Solidarity With the Palestinian People, Shelia Ryan from the New York City-based Middle East Peace Network presented a talk and answered. questions focusing on the economic, political, and personal aspects of the Palestinian Uprising as well as the role the US assumes in the Middle East conflict. Following her talk, she presented her proposal for a Middle East Peace Campaign which would attempt to bridge the gap between public opinion and congressional action by gathering signitures on a two sentence statement endorsing a two state solution. The response to her campaign was enthusiastic and the committee will be following up on it in 1989.

At an Israeli Defense Ministry sponsored US-Israeli Defense Industry Conference last fall, Strategic Defense Initiative director Lt. Gen. James Abrahamson boasted that "Israel is the first among allied nations in total value of contracts awarded for participation in SDI."

Nobel Prizw winner Elie Wiesel continues his moral cowardice. The Jewish World reported (Oct. 20) that Mr. Wiesel said he would not judge Israel or criticize it over the methods used to respond to the Intifada.

On Dec. 22, the Rev. Jesse Jackson called upon Israel to join with the Palestine Liberation Organization in its renunciation of terrorism. He said there must be a joint commitment.

In a case involving Palestinians, a US District Judge, on Dec. 22, declared unconstitutional two sections of the 1952 McCarran-Walter Act, a vicious anti-free speech law passed at the height of the anti-communist hysteia following World War Two.

THE STATE DEPARTMENT REPORT ON HUMAN RIGHTS

The U.S. State Department on February 8th released it's annual report to the U.S. Congress on the status of Human Rights in various foreign countries. In the report the State Department heavily criticized Israel's behavior in the occupied West Bank (including East Jerusalem) and the Gaza Strip. The State Department acknowledged Israel's behavior contravenes the Forth Geneva Convention, International Law and recognized human rights standards.

The report accuses Israel for using excessive force and excessive punishment in dealing with Palestinians in the Occupied Territories. Israel has "frequently used gunfire in situations that did not present mortal danger to troops causing many avoidable deaths and injuries". It highlights torture and other cruel punishment; arbitrary arrest; detention and exile; denial of fair public trial; collective punishment; lack of respect for civil liberties; and political killings. The report details a situation that has been well known to anyone who cared to know what has been going on.

Al Haq / Law in the Service of Man in a statement released february 10th said "that despite serious flaws and omissions, the State Department had decreased it's use of loaded language and reduced it's tendency to justify Israel's violation of human rights". This is the first time since 1967 that the U.S. State Department has offered the American Public a "glimpse of what occurs on a daily basis in the Occupied Territories".

There is an attempt to assign partial blame on the Palestinians and there is an element of special pleading for the Israeli Defence Forces (IDF). The report stated, "the IDF, caught by surprise and untrained and inexperienced in riot control". The IDF were not caught off guard. The Intifada is the inevitable result of denying the Palestinians their rights. Nor is there any reason why the IDF would be untrained and inexperienced. They have been suppressing the Palestinians for over twenty years. Many violations were also excluded such as the closure of schools, charitable institutions, labor unions offices, as well as the cutting off of international telephone lines and domestic communications.

The State Department is mandated to issue a report to the U.S. Congress by Public Law 94-329 for all countries the Executive Branch is proposing to give military or economic aid to any country whose government "engages in a consistent pattern of gross violations of internationally recognized human rights" It is the United States which has provided the money, the arms, and the vital political support which allows the Israeli Government to carry out it's oppressive measures.

LOCAL ZIONISTS, "DECISIVE FACTOR" IN JIM BLEIKAMP'S FIRING

Former WGY (81AM) late evening talk show host Jim Bleikamp stated a local Zionist organization was a "decisive factor" in his being fired. The Shield of David, a recently formed pro-Israeli organization claimed responsibility in an interview with UPI. On his 3 hour show, Mr. Bleikamp frequently stated his support for a Palestinian state. The Shield of David said Bleikamp's stance made him an anti-Semite.

Jim Bleikamp had received many callers on his program labeling him as an antiSemite. One caller, Al Herman, clashed with Jim on the air and it led to Jim banning
Herman from the show. Bleikamp said Herman's arrogance and constant inaccuracy on the
facts caused the ban. Many local people would agree with Jim's perception of Herman.
Unfortunately, the banning of a caller gave the management of the radio station an "easy
out" to fire Jim.

Prior to the termination of Bleikamp's employement, Stanford Rosenblum, a local attorney, said he had contacted the station threatening to take legal action if something was not done about Bleikamp. Dennis Israel, owner of WGY, said he questioned Jim's use of the word "genocide" to describe the policies of Israel toward the Palestinians.

Fred Dicker, a well-known reporter who used to be with the New York Post, and a strong supporter of Israel, defended Bleikamp, saying Jim was neither anti-Semitic nor anti-Israel. WGY's management has denied any outside pressure was involved in their decision to fire Bleikamp. Dennis Israel, a Republican Party activist, said it was Jim's insubordination that caused his being fired. It is well known that Mr. Israel was very angry with Bleikamp's on-the-air criticism of Presedential candidate George Bush last fall.

Jim Bleikamp subscribed to an unwritten rule - when a guest on the show was speaking up for peace and justice for the Palestinians, you must have a Zionist counter guest. When committee member Tom Ellis, was a guest on the show, Jim Bleikamp tried unsuccessfully to have a pro-Israeli on the same show. Michael Winograd of the Anti-Defamation League of B'nai B'rith refused to appear and other Zionists were not available on short notice. When Shelia Ryan, the director of the Middle East Campaign, was a guest, Jim was able to get Steven Berk, a history professor at Union College, to present the a pro-Israeli point of view.

We at the Capital District Committee for Palestinian Rights consider this incident to be very serious. We must stop the intimidation of supporters of Palestinian rights. Advocating a Palestinian state is not an anti-Semitic act. We have every right to criticize and condemn the vicious and sadistic policies of Israel. CPR members should inform their friends about the unjustified firing of Jim Bleikamp.

ANTI-RACISM FRONT PROTESTS KAHANE AT SUNYA

75 people from area organizations gathered in front of Page Hall (downtown) on Feb. 13 to protest a lecture given by the notorious Meir Kahane. Signs were carried stating "Kahanism is Racism," "Kahane Preaches Hate," and "Kahane doesn't Speak for this Jew," and chants and shouts were exchanged with about 25 pro-Kahane demostrators.

The lecture, which was announced only a week in advance, activated many organizations and individuals. The Coalition Against Apartheid and Racism activated their phone list and had a strong vocal presence. The Minority Affairs Council of SUNYA confonted SUNYA's President on the issue. LONG LIVE THE INTIFADAH

Entering its 16th month, the Palestinian intifadah has set a course of liberating the occupied territories from Israeli occupation and towards the fulfillment of a Palestinian State. The "children of the stones" have fought back with enormous foritude and imagination, posing the greatest challenge to Zionist expansionism. Israel has yet to put forth concise, reasonable, peace iniatives comparable to the PLO's peace plan. Until it does the political violence will continue, possibly to levels we have not seen.

Moitivated by the same desires and aspirations for peace, freedom, and justice as all the world's people, Palestinians have fought with rocks against M-16's, victory gardens against captive markets, and general strikes against slave labor. Paraphrasing a collegue's recent statement- you can't relegate the indigenous population to the floral and fauna of the environment and expect them to go away and not struggle.

The editorial in the March-April issue of Middle East Report states clearly the Intifadah's revolutionary dimension. "The Uprising continues because it embodies a social revolution that has irreversibly altered relations between men and women, old and young, village, camp, and city, rich and poor. And between Palestinian and Israeli. It is this revolutionary dimension that has empowered the Palestinians to fight against awesome odds to break the colonial regime- a regime imposed by Israel but extending back into earlier decades of Jordanian and British rule.".

In its Feb. 16th issue, the locally published Jewish World newspaper reported how a B'nai B'rith international spokesperson had said that group will print a retraction to 14,000 persons who had received a fundraising letter which said "The Arab presence on the [U.S.] college campus is poisoning the minds of our young people."

The American-Arab Anti-Discrimination Committee (ADC) had crictized the letter, which was signed by B'nai B'rith President Seymour Reich.

On March 2, Faris Bouhafa, Director of Media and Public Relations for the ADC said that the promised letter of apology had not been seen yet "by anybody on their [B'nai B'rith] mailing list or by the press."

The B'nai B'rith is the world's largest Jewish organization, to which the Anti Defamation League (ADL) is affilated. For well over 20 years the ADL has been printing racist comments about Arabs similiar to what was contained in the B'nai B'rith letter.

It is really tragic that the world's largest Jewish organization in the US can wantonly display intense hatred towards Arabs. The ADL has been, for decades, producing reports on racism and anti-semitism. They shuculd take a serious look at racism within the Jewish community.

EYEWITNESS REPORT: "NO ONE IS IMMUNE FROM BEATINGS!!"

Craig Mokhiber gave a lecture at Suny Albany on Feb. 2. event was sponored by the Capital District Committee for Palestinian Rights and the Student Committee for Palestinian Rights.

Mr. Mokhiber participated in the "Eyewitness Israel" program organizered by the American-Arab Anti-Discrimination Committee (ADC). His visit to Palestine and Israel last summer was sponsored by the Buffalo chapter of the National Lawyers Guild.

He said the Isralei abuse of Palestinians is so overwhelming that "documenting human rights violations in the West Bank is like looking

for sand in the desert.

Mr. Mokhiber said, "There is no way to describe the smell of rotting garbage, open sewers and burning tires or the sound of mothers pleading to Israeli soldiers for their sons, or clubs hitting people's

He said the "streets are literally littered with tear gas canisters and bullets.

In response to oft-heard claim that soldiers and settlers do not routinely violate international law, he said doctors frequently report systematic and sadistic beatings, gas is used extensively and in enclosed areas. "There is a total denial of legal due process"and that "razor wire is everywhere."

He said no one is immune from beatings, leaflets appear out of nowhere and that "Israeli run hospitals in the territories are sewers,

toilets.'

He explained that while Israel nearly crushed Palestinian resistance from 1967-87, today the Palestinians are dug in for a long struggle. He said "terror and horror are everywhere but the people are optimistic and will never go back to the 1967-87 complacency.

In his conversations with peace-loving Israeli's he was told that more and more Israeli's are becoming right-wing. In conclusion he said the solution to the conflict will come from the U.S, not from within Israel.

Mr Mokhiber impressed a student from RPI that he has been invited to speak to the RPI campus on March 30th, Land Day.

Namibia, formerly kmown as South West Africa, and Palestine, are the only nations left from the Mandate system which have yet to gain their independence. SWAPO is the sole authentic representatives of the Namibian people, and is the national independence movement of Namibia.

Namibia was colonized by Germany in the 1880's. After WWI, the League of Nations then gave South Africa a Mandate for the region where, throughout the 20th Cenury, South Africa has promoted its brand of white supremacist rule. In 1966 Namibia was placed directly under the U.N. and South African rule of the region was regarded as illegal. However, South Africa refused to leave. In 1978 the U.N. Security Council passed Resolution 435 which called for the total independence of Namibia.

SWAPO's liberation ideology cuts across racial, religious, ethnic and cultural lines and mobilizes all Namibians.

SWAPO's political support inside Namibia is extensive, and if a free, fair and demcratic election were held in Namibia SWAPO would win hands down.


The Brazzaville Accords were signed in December, 1988, by Cuba, Angola, and South Africa. These accords called for the implementation of U.N. Security Council Resolution \$435. Recently decisions by the Security Council, however, have threatened the proposed Namibian elections, setting the stage for ongoing South African interference

On March 4th in a meeting held at a member's house, CPR organized a subcommittee titled, the Palestinian Cultural Association (PCA). Two Knesset Members, Dedu Zucker and Yossi Sareed of the Civil Rights Party, recently wrote a letter to Israeli Attorney General Yoseff Harish. They stated Jewish settlers militia have been preparing for civil war and should be disbanded.

The militia is organized in local units of platoon or company strength, led by a central headquarters and coordinated by technologically sophisticated communication systems. The militias often conduct intimidating and punitive operations against the Palestinians; Such as: entering houses, destroying property, burning agricultual fields and orchards, and molesting and beating the Palestinian people.

The letter stated that the settlers' militia draw encouragement from the "permissive attitude on the part of the security forces and law enforcement agencies", as well as from the support of right-wing parties and elements in the government.

Israel Publishes, "Verses"

I couldn't help but notice that Israel decided to publish The Satanic Verses by Salmon Rushdie. Is this a question of protecting civil liberties or to agitate the Islamic community in Paslestine? I believe the latter. Israel was praised by the evangicals in the US for banning the movie The Last Temptation of Christ. Israel has also banned over 2,000 books in the Occupied Territoies.

Elections dispel myths

Israeli statistics on the Jerusalem municipal elections showed that less than four percent (some reports said not even one percent) of eligible Palestinian voters (eligible by reason of Israel's illegal annexation of East Jerusalem, not by Palestinians feeling as citizens of Israel) cast a vote in last week's elections.

The message in this should be clear: even after 20 years of occupation and annexation, Palestinians in East Jerusalem do not feel any affiliation to the Israeli state, not even on the municipal level.

Veteran West Jerusalem Mayor Teddy Kollek ran for re-clections on the One Jerusalem list. His motto was a united Jerusalem with equal services for the city's 300,000 Jewish and 120,000 Arab residents. The Jews live in West Jerusalem and the Arabs live in East Jerusalem.

Teddy Kollek's all-Jewish municipal council tried to convince East Jerusalem's Palestinian population to vote for him. He cited services provided for East Jerusalem as proof of his evenhanded policy and supposed equality of services for Jews and Arabs. Yet, less than four percent went to the polls this year, most of them employees of the municipality and their families who probably feared Kollek would dismiss them from their jobs if their identity cards did not show a stamp proving that they voted.

The reasons the Palestinians did not participate in this year's elections (previous years also showed a relatively small percentage of Palestinians voting in the municipal elections) are political and otherwise. Political, in the sense that Palestinians have never felt part of Israel and have continued to await for salvation through an end to occupation and the creation of the independent Palestinian state. Voting for city council or anything else meant they gave up this dream and accepted the occupation, something the vast majority of Palestinians do not want.

Otherwise, in the sense that Palestinians in East Jerusalem, through their past 20-year experience under occupation, have never felt they have been treated equally to the Jewish population of West Jerusalem. Services have always been lacking and the municipality and government in general never lost an opportunity to undermine Palestinian infrastructure, whether it was industry, education, health, housing, roads or business in general. Even though Palestinians in East Jerusalem have paid taxes throughout the occupation years, the services they received in return were nothing compared to the amount of money they paid.

Kollek ran on the theme of a united Jerusalem, but election results showed that Palestinians do not agree with him. The elections showed that a united Jerusalem is only an Israeli dream, not a reality on the ground. The story of Jerusalem should tell the story of the entire occupied territories. da activated their phone list, attended in full, and distributed a laeflet titled "Kahane's Kippah (yarmulke) Doesn't Cover His Racism." It was an excellent example of unity in confronting and isolating advowed racists. The committee thanks everyone who took part and help to make it a successful event.

Rabbi Meir Kahane is the American born founder of the Jewish Defense League (JDL) and the Kach party in Israel. Kach party has called for the removal of Palestinians from Israel and the West Bank and Gaza. Kahane has advocated the destruction of the Dome of the Rock mosque in Jerusalem.

Kahane constantly tours the U.S. raising money for his hate campaigns. He has three fund raising organizations in the U.S.; "Kach International, "Institute for the Authenic Jewish Idea," and the "Jewish Overveiw." There has been a consumer boycott of Haagen-Dazs Ice Cream as founder and chairman Reuban Mattus has made vast financial cotributions to Kahane and the JDL.

The JDL was created in 1968 as a vigilante organization, it later escalated to harassing Soviet cultural events and firebombing Soviet missions in New York City. Recent JDL terror is almost solely directed at Palestinian students and Arab-Americans. A federal grand jury in 1987 in Brooklyn investigated the JDL in connection with bombings, extortion, homicides, and kidnapping; including the 1985 bombing of the American-Arab Anti- Discrimination Committee(ADC) office in Santa Anna, CA, killing Aiex Odeh.

Kahane's appearance on the campus has done absolutely nothing to heal the wounds of racism. The Revisionist Zionist Alternative showed complete irresponsibility as the event will led to further polarization on campus.

Many people spoke out in the lecture. Which was poorly attended, and a few were thrown out. The demostration received excellent coverage by the electronic and printed media. The next time Kahane appears in the Capital District we should have 200 people demostrating.

Sane/Freeze, the largest peace organization in the United States which resulted from a recent merger of the Committee for a Sane Nuclear Policy and the Nuclear Freeze Campaign, passed its first resolution on the Palestinian/Israeli conflict at its 2nd congress in Atlanta, Georgia, in December. The resolution, passed by a huge majority, reads: "Be it resolved that Sane/Freeze call upon the U.S. government to: 1) support the right of the Palestinian people to selfdetermination and a state of their own in the West Bank and Gaza alongside Israel. with peace and security for both states; 2) recognize the PLO as the chosen representative of the Palestinians; and 3) support the convening of an international peace conference with the participation of the PLO, Israel, the neighboring Arab states, the United States, and the Soviet Union." Sane/Freeze's resolution is evidence that the peace movement has begun to move on Palestinian rights.

The Capital District Committee for Palestinian Rights (CDCPR) was organized in response to the Israeli invasion of Lebason during the summer of 1982.
