

Misplaced blame promotes fear

Editor:

Every week in The Jewish World I read multiple articles about how Jewish organizations are calling for the end to this or that anti-Israel or anti-Jewish work of art or other public expression. Instead of asking artists and activists to engage with us in a discussion so that we may learn what is fueling their feelings, we simply complain and attempt to censor them. We do this out of fear—fear that if this sort of rhetoric is not censored, then it will encourage acts of violence against Jewish people.

I believe that people who make anti-Israel statements have significant concerns with Israel's policies. It is only because we "play the anti-Semitic card" and attempt to censor them, that they begin to find that the only way Israel will listen to their concerns is if they bomb a bus. They are wrong of course—violence is not dialogue—but it is because we so clearly are not listening to their concerns, that we encourage them to resort to these more violent means.

Anti-Semitism, in general, comes from oppressed people, who are misguided in where to place their anger and frustration over their own situation. I have attended school in Lewiston, Maine, for the past two years and saw an influx of almost 2,000 Somali refugees to this very white city. Lewiston has one of the poorest communities in all of Maine, and so when neo-Nazis came to our town, they got a lot of support convincing Lewiston residents that their economic woes were due to Somali refugees eating up all the city's money through welfare programs. This was as much a lie as the Nazi successful pitch to Germans that their own nation's problems were due to the presence of Jews in society.

The Jewish World's articles respond to this misplaced blame by promoting fear. This fear leads us to censor and blacklist, to ridicule and demoralize, and to have no sympathy for the people who spread anti-Israel or anti-Jewish thought.

But these people, just as Nazis, or Al-Qaeda, or Palestinian militants, have important concerns and are crying out for justice. Yet we always just play victim,

Finklestein Says The Gaza War Was A Massacre

Norman Finklestein spoke November 17, 2010 at the University at Albany. The Palestinian Rights Committee, the student Justice and Peace in Palestine Alliance, and the university chapter of Amnesty International cosponsored his appearance.

He devoted much of his prepared comments to the 2008-2009 Israeli massacre in Gaza and said if anyone is to condemn Hamas for its firing rockets into Israel, (s)he should also be able to identify what alternatives were available to Hamas.

Refuting assertions that the massacre was a "war," he said the ratios of people killed were 100 Palestinians to 1 Israeli, civilians killed 400-1 (actual numbers 1200 to 3), and houses destroyed 6000-1. With such one-sided ratios, how can anyone say it was a war? In response to a question about Israel making 290,000 telephone calls to Gaza urging people to take cover prior to these attacks—the implication being that Israel was trying to minimize civilian casualties—he said Gazans are locked inside Gaza, had no place to hide safely during the massacre, and thus the phone calls were in effect designed to further terrorize Gazans.

Regarding the possibility of Israel successfully negotiating with Hamas, he said Hamas has not referred to its charter in 15 years, Hamas has often said it will accept an agreement with Israel along the pre-1967-war borders, and Hamas and Israel have made agreements before such as the June 2008 ceasefire brokered by Egypt that Israel broke on Nov. 4, 2008—Election Day in the United States when much of the world's attention was focused on the election of Barack Obama—when little attention would be paid to Israel murdering Gazans. He said Israel should call Hamas' bluff to see if Hamas is serious about what its leaders proclaim.

Mr. Finklestein said no tangible improvements in life of Gazans have occurred since the Israeli siege was supposedly partially lifted last spring, according to comments made a few days earlier by John Ging, director of Gaza operations of the United Nations Relief and Works Agency for Palestinian Refugees in the Near East.

Norman Finklestein earned a doctorate from the Department of Politics at Princeton University in 1988 and has written several books including "Beyond Chutzpah: On the Misuse of anti-Semitism and the Abuse of History" (2005) and "The Holocaust Industry: Reflections on the Exploitation of Jewish Suffering" (2000). He has taught political theory at DePaul University.

He correctly called the 17-year peace process a "farce" and claimed it should be labeled an "annexation process." No settlement freeze occurred during 2010 despite claims by Israel that it had. Finklestein said six months prior to the start of the "freeze," current Israeli Prime Minister Netanyahu told settler leaders to use the next six months to lay foundations, and then finish constructing the homes during the "freeze" which concerned "new" construction.

On the positive side, he believes a "sea change" has occurred among US Jews, especially youth, in recent years on the issue. Few Jews wish to publicly endorse universally acknowledged ongoing war crimes. He encouraged listeners to be "principled" and "reasonable" in our work. By "reasonable," he meant showing we are not an obstacle to resolving the conflict. Finklestein quoted someone who has insisted, "There is room for everyone at the rendezvous of victory," meaning a real solution to the conflict is a win-win for everyone.

He said he is neither pro-Palestinian nor pro-Israeli, or anti-Israel or anti-Palestinian, but pro-justice, and if the conflict were reversed with Palestinians occupying and periodically massacring Israelis on a massive scale, there is no doubt where he would stand.

"Politics is getting people to act on what they know is wrong," he said, quoting Gandhi, whom he referred to several times. Asked about a one-state versus a two-state solution to the conflict, he said he does not support a one-state option because it would amount to the destruction of Israel. Asked about the Israeli withdrawal from the Sinai Peninsula thirty years ago, he said lack of success in the 1973 war convinced Israeli leaders the Sinai would be difficult to retain over the long run. Another reason Israel exited the Sinai was to make peace with Egypt thus splitting Arab nations in their opposition to Israel and removing Egypt as a war adversary.

The United Nations General Assembly often votes often go 140+ to 6, he said, with the US and Israel joined by three or four US protectorates (Micronesia, Marshall Islands, Palau) as the only nations siding with the US and Israel. He mentioned that not only have all 22 members of the League of Arab States voted unanimously to offer Israel a real peace (in 2002, 2007, and 2009) but so have all 56 nations in the Organization of Islamic Conference.

limited success. These are legal approaches, non-violent civil disobedience, and boycott, divestment, and sanctions

An example of a legal strategy was the recommendation contained in the report of South African jurist Richard Goldstone and his colleagues for the United Nations to take specific steps if Israel failed to follow through on the report's recommendations. An example of non-violent civil disobedience was the "Freedom Flotilla" that Israel attacked

on May 31.

He said the BDS campaign will not succeed unless and until its goal(s) is clear, which it is not now. He said it is appropriate to boycott universities or corporations that profit financially from the Israeli occupation of universally acknowledged occupied Palestinian territories-the West Bank, Gaza Strip, and East Jerusalem. A comprehensive arms embargo is an excellent idea to champion, and it can be justified as a response to Israeli government violations of law. A targeted campaign to block Caterpillar Corporation sales of D9 bulldozers to Israel is supportable because it can be justified due to the bulldozers being used to destroy Palestinian homes in violation of international law.

Israel's security fence incites more violence

This is in response to Michael Kohn's letter ("Worse offenses exist in the world than Israel's security fence," July 29)." Maybe Mr. Kohn does not realize the effects of this "illegal" wall, which may explain why he attempts to rationalize it by asking us the extent of the wall's illegality on a scale of one to 10.

The 8-meter high concrete wall, razor-wire fences, trenches and watchtowers will stand to cut off the Palestinians not just from Jerusalem, but also from other towns and villages. This would mean that thousands of Palestinians will be separated from their relatives, their workplaces, the schools that most of their children attend and where they shop for their necessities.

The wall will inhibit important trade carried out between Israel and the Palestinian towns and cities. This means that thousands of people are at risk of losing their sources of income.

The West Bank is being transformed into a city of cages or enclaves where the only way out is through a series of special roads, tunnels or bridges manned by Israeli officers who have the power to deny access to anyone they please.

Outside these cages, Palestinians are further frustrated by Israeli-only roads, heightened scrutiny by guards, expanding Jewish settlements and a stronger military presence.

This nightmare is fast becoming a reality for thousands of Palestinians. Does Israel really think that locking Palestinians up in these walled cages, taking away their sources of income, keeping their children from attending schools and limiting their freedom willresult in peace? Has history ever shown these tactics to work? Instead, these will... incite the Palestinians even more and unite them in the fight against Israel. Where there was one suicide bomber there will now be 10.

Israel would be wise to take the International Court of Justice's recommendation into consideration. Two wrongs do not make a right. We would all like to see a stop to the suicide bombings and a lasting peace in the Middle East, but Israel's wall will incite violence, not hinder it.

Over 110 Palestinians had been killed in May, the current razing of homes in Rafah (Amnesty International calls a War Crime), missile attacks and extra-judiciary assassinations, and placing Gaza under Siege; the continued building of a 450 mile Wall in the West Bank- destroying villages, farms, and economies; lack of a US Gov't response to these acts, it's recent declaration of support for settlements, the continued financing of occupation and the use of US-made Apache helicopters, Armored Caterpillar bulldozers and tanks.

TEAR DOWN THE APARTHEID WALL

At the end of July 2003, the Israeli government misleadingly announced the completion of the "first phase"—145 km from some 600km—of the Wall that it began erecting inside the West Bank in June 2002. In fact, bulldozers continue to ravage the northern West Bank by building buffer zones and expanding sections of the Wall. The Wall—falsely declared a "security barrier" by the Israeli military—is the largest land grab since the Occupation began in 1967; when completed the Wall will de-facto annex nearly 50% of the West Bank by the Israeli government.

The Wall effectively annexes West Bank land on which Illegal Jewishonly settlements were built and confiscates prime resources, turning
the West Bank into a series of cantons and enclaves in a
bantustanization of the area. The Wall has already taken over the
lands of dozens of Palestinian communities and stolen the livelihoods
of thousands of families in the northern West Bank as well as in the
Jerusalem and Bethlehem areas. The US Administration has yet to
exert pressure on the Israeli government to stop building and start
dismantling the Wall. It is up to US citizens to demand that the US
Administration hold the Israeli Government accountable for
international law, and to coordinate their actions to stop the Wall and
promote freedom for the Palestinian people and peace and security
for all.

Attack of Arab armies caused creation of Palestinian refugees

It is clear from Kay Kelly's letter of May 22 that there is more than one opinion about which side is most at fault in the Israeli-Palestinian conflict. Some of her assertions, however, defy logic.

Arguing about whether the Palestinians fled their homes at the urging of their own Arab leaders or, as Ms. Kelly believes, in fear of "Zionist attacks," is mostly an exercise in futility. Fifty-six years after the fact, historians continue to vigorously debate this issue.

However, the inescapable fact conveniently omitted by Ms. Kelly is that there would not be even one Palestinian refugee had five Arab armies not attacked Israel in 1948 when it declared independence pursuant to the United Nations Partition Plan for Palestine. All wars create refugees. No one disputes that Israel's War of Independence was started by the Arabs.

Her outrage over the fact that the Negev region given to the Israelis remains mostly unpopulated is also misplaced. Giving her the benefit of the doubt, perhaps she doesn't know that this area, which comprises nearly 60 percent of modern Israel, is a barren desert that is largely uninhabitable. It would be

prohibitively expensive to settle a large number of people there, assuming that the resources were even available. Unfortunately, Israel isn't blessed with an abundance of water as is New York state. By the way, no population centers, Palestinian or otherwise, ever existed in the Negev prior to 1948.

That being said, it is hardly unusual to find a country's population centered in a few metropolitan areas. There are many economic and social reasons for this. Uneven population distributions are the norm throughout the world.

Here at home, more than 8 million people live within the 310 square miles of New York City. Fewer than 300,000 live within the 530 square miles of Albany County. Is Ms. Kelly suggesting that we should start resettling the residents of Manhattan and the Bronx in upstate New York?

Should Brooklynites be forced to settle in the Adirondacks? Maybe we could ease traffic congestion in Los Angeles by moving more people into the Mojave Desert, or natives of Cairo, Egypt into the Sahara. Why does Ms. Kelly have one rule for Israel and another for the rest of the world?

How ironic it is to read a complaint from a pro-Palestinian about Israeli access to the sea. Perhaps the reason why the U.N. plan gave Israel access to the Gulf of Aqaba through the Negev was because it knew that no adjacent Arab country would grant it the same right. On the other hand, who would believe that Egypt or Jordan would have denied such access to a Palestinian state?

Finally, I object to Ms. Kelly's liberal use of the term Zionist. Although most Jews and Israelis think of themselves as one kind of Zionist or another, no one uses the term as a means of identification. The only people who still call Israelis by the term Zionist are organizations like Hamas or Islamic Jihad (or their sympathizers) that are bent on the total destruction of Israel.

By substituting Zionist for Israeli, the intent is to delegitimize Israel as a political entity. It transforms Israelis from a people with a right to a nation into a people who only have a philosophy (a love for Zion). It would be similar to Native Americans still calling Americans of European descent Colonists or Pilgrims.

Payments could ease anger of Arab refugees

This is in response to the April 2 letter of Mark Kelly. Any hatred toward the Israelis comes from the expulsion of Arabs from their land in 1948 and the expropriation of their land, houses, crops and businesses.

It has been more than 50 years, and Israel has not paid compensation. (Scholars have studied this problem; see most recently Michael Fischbach's book "Records of Dispossession.") Studies have been made of German compensation to Jews from the Holocaust and applied those principles to Israeli compensation to Arab refugees. I should think those should be followed here (and, I might say, to compensation by other nations to their refugees).

An acquaintance has told me of a proposal to have America and Europe contribute to a fund for compensation. Then the refugee might have a stake to go elsewhere. This could diminish the killing and show the Arabs that we are not their enemy.

After some thought, I think I might support such a proposal — it may save lives, including American lives. All of this deserves much more discussion than it is getting.

Hold Palestinians,

Israel to same standard

Your March 24 editorial, "A new Mideast cycle," regarding the murder of Sheik Ahmed Yassin, spiritual leader of Hamas, the militant Palestinian resistance group, was filled with misinformation and ignorant statements. Describing Palestinians as "those who welcome nothing more than an unending cycle of bloodshed," the editorial portrays an offensive yet commonly mistaken view of Muslims.

The assassination was described as a "matter of bringing an architect of murder to justice." The problem with this statement is twofold. First, it assumes that Yassin was an architect of murder; second, that the assassination was a "just" act. If indeed Yassin was the former, why then was he not simply arrested and thrown in jail? Why did Israel feel the need to use a military air strike to do the job, and kill 11 innocent bystanders as well? If the Hamas threat was so severe, Israel could have taken out the elderly paraplegic years ago.

The real reason is more probably Prime Minister Ariel Sharon's desire to depart Gaza while maintaining his reputation as a callous hardliner, for fear of repeating former Prime Minister Ehud Barak's "mistake" of exiting Lebanon without a fight in 2000. If this is the case, the murder is most certainly unjust. The editorial mentions the 300 Israelis killed by Hamas in recent years as justification for the assassination; however, it fails to mention the 2,000 plus Palestinian men, women and children killed by Israeli forces, or the numerous homes and livelihoods demolished as well.

The least we can do as Americans is equally condemn violence, instead of propagating anti-Muslim sentiment by holding Israel to a different standard.

A Brief History Of Palestine And Popular Resistance

Mazin Qumsiyeh spoke June 22 in Saugerties about "Popular Resistance in Palestine: A History of Hope and Empowerment." About 35 attended at a downtown book store.

Qumsiyeh, born near Bethlehem in 1957, has a Ph.D. in biology, is a medical geneticist, Christian, U.S. citizen, and founded and directs the (1) Palestinian Museum of Natural History and (2) The Institute for Biodiversity Research at Bethlehem University. These institutions conduct research, educate, and conserve the natural world and Palestinian culture and heritage.

He began and repeated several times that "diversity is strength" and is superior to mono-cultures of any and every type. He said Palestine is rich in human and non-human genetic material partly due its location at the bottleneck of Eurasia and Africa. "Palestine," a word in usage for 3,000 years, was used by Herodotus. Jesus was a Palestinian Jew. The land of Palestine is exceptionally wealthy in ethnic groups, languages, and religions.

Dr. Qumsiyeh said Zionist leader Theodor Herzel (d. 1904) told European leaders that a Jewish presence in Palestine

would be a bulwark of European civilization in Asia, Zionist leaders won French and British governments support for their cause during World War I by pledging to help bring the US into the war, and David Ben-Gurion (first Israeli prime minister) came up with the "two-state" solution in the 1920s, knowing Zionists could use it for propaganda purposes despite their intent to take all or as much of Palestine as they could.

There are more Jews, Qumsiyeh said, per square kilometer in the West Bank now than within the 1949-1967 Israel borders, Palestinians now possess 8.3 percent of the land in historic Palestine, and since 1948, more than 100,000 Palestinians have been killed, 800,000 injured, and 700,000 detained by Israel. About 7.5 million of 13 million Palestinians are now dispossessed from their lands.

He said colonialism was a common human activity for millennia, colonizers do not want the colonized to have lives or livelihoods, and colonizers can never respect the sovereignty of the colonized. He insisted it is vital to call colonialism by its correct name; doing so allows one to make a correct diagnosis of reality.



He said Israel often uses butterfly bullets on Gazans; such bullets greatly expand as they pass through human flesh. More than 100 Palestinians have been killed since late March and at

least 10,000 injured.

While incarcerated in Israeli prisons, he taught biology and languages to fellow prisoners and guards while learning everything he could from them. Protesting, he said, is not enough, although it is important, but Palestinians should be building institutions. He said the Palestinian Authority subcontracts the occupation for Israel and Gaza is experiencing genocide. ❖





Arafat has been criticized for not accepting a take it or leave it "peace plan" from Israel that did not even meet the minimum requirements for a true, independent and free homeland and which did not include even a small, long time and very holy Muslim section of East Jerusalem.

Israelis have steadfastly refused to give back meaningful sections of land they took from Jordan, including the West Bank and East Jerusalem, in the 1967 war, on which, of course they have been building settlements for 40 years. Arafat was not a perfect man but he dedicated his life to winning back a homeland for his dispossessed people. His failure to accomplish that must be shared by many people. He did, however, make real a dream that will not die until the Palestinian people get a home land and a country of their own. And this will be his final legacy.
